vehicle crash that occurred at approximately 7:30 a.m. on Wednesday, Feb. 1, near Andrews.

Kaser was a passenger in a 2006 Honda CRV, driven by 20-year-old Meghan Blaylock of Murphy, North Carolina.

Blaylock also died from injuries sustained in the crash.

The Honda driven by Blaylock was traveling westbound in the eastbound lane and met a 2011 Ford Expedition, driven by 57-year-old Carver Odell Wilson of Andrews that was traveling east, according to North Carolina authorities.

Wilson tried to swerve out of the way and miss the Honda CRV, but the vehicles collided head-on, according to the patrol.

Kaser died at the scene; Blaylock was transported to Erlanger Hospital in Chattanooga, Tennessee, and later succumbed to injuries sustained in the crash.

Wilson was transported to Murphy Medical Center and later transported to Erlanger for medical treatment of injuries sustained in the crash.

The crash remains under investigation, according to the patrol.

Funeral services for Kaser were held on Saturday, Feb. 4, at Mountain View Funeral Home's Chapel in Blairsville. The Rev. Greg Huskins officiated.
