Phillips resigns from EMC board for personal reasons

The man who started the petition ballot revolution on the Blue Ridge Mountain EMC Board of Directors in 2014 has

Steven Phillips, a representative from Towns County and the vice chairman of the BRMEMC Board of Directors, has tendered his resignation from the board for personal reasons, BRMEMC Chair Mickey Cummings said

Friday.

"This board is what it is today because of Steven Phillips," Cummings said. "Steven simply stated that he was resigning for personal reasons, and he did not

Director Ray Cook will replace Phillips as chair of the EMC's policy committee in the interim, Cummings said. Phillips bested Incumbent

Julie Payne with 69.1 percent of the vote to Payne's 28.1 percent in the September 2014 election at BRMEMC's annual "This election meant everything to me," Phillips

said after he learned he had been elected to the board of directors. "I think it's time for change, and obviously so did the membership."
Phillips, former House

BOE to accept millage rollback rate as property values increase By Shawn Jarrard up by about \$750,000, and the

The Union County Board of Education voted in its July 18 regular meeting to set the 2017 tentative school millage rate at the rollback rate of

The 2017 rate is down slightly from the 2016 rate, which was 11.787 mills, though due to an increase in existing property values and added property since the 2016 tax digest, the schools will be bringing in roughly \$213,000 more in tax revenues this year over last year.

Under last year's millage rate of 11.787 mills, the schools projected to collect \$14,205,828 in 2016 property taxes.

Accepting the rollback rate of 11.780 mills will bring in \$14,418,723.24 in net taxes levied this year toward the system's FY18 budget, or roughly \$213,000 more in tax monies in 2017 than in 2016.

Again, this additional tax revenue for the schools comes from property gains made within the county, as existing real property values have gone

county has experienced a net gain of about \$18 million in property values since 2016. Thanks to relatively

stable property values in recent years, which have seen an increase this year and last year, the school millage rate has either decreased or stayed the same since at least 2011.

'As you look at the data that we've provided,' said Union County Schools Superintendent Dr. Fred Rayfield to the board in that July 18 meeting, "it's the first time in a while that we've had a good increase in the digest, which puts us in a positive position so that we might be able to recommend a millage rate to you that is a rollback from the rate that we are currently under.'

Final adoption of the 2017 school millage rate is slated for the Tuesday, Aug. 15, regular meeting at the Union County Board of Education office at 7 p.m.
