Also indicted in unrelated crimes, Jeffrey Dean Cowan, 56, of Blairsville, criminal attempt to commit a felony, armed robbery, three counts aggravated assault, hijacking a motor vehicle, false imprisonment, terroristic threats, possession of a knife during the commission of a felony, Superior Court records show.

At around 2:30 p.m. on the afternoon of Sunday, April 23,2017 Cowan was picked up from Union County Jail by local bondsman Buck Dills, according to Lt. Osborn.

Dills was in the process of bonding Cowan out Sunday from a weeks old theft by taking charge, and Cowan told Dills that he needed to be driven to the Booger Hollow Store on Gainesville Highway to get the bond fee money from his waiting wife, according to Lt. Osborn.

No wife awaited them

store, and Cowan cut Dills with a knife, then ran over to the neighboring Dollar General, according to Lt. Osborn. "He went into the

when the two arrived at the

"He went into the Dollar General Store and held a knife to the clerk's throat, and threatened to kill her if she didn't give him the keys to her car," said Lt. Osborn. That's how Cowan came

to be driving an orange 2007
Honda Fit, according to Lt.
Osborn.

Cowan was apprehended without incident by police in Marion, Illinois, on Wednesday, April 26.

Cowan, 56, of a Blairsville address, had been on the run since his violent disappearing act on Sunday, April 23.

Cowan was also indicted for theft by deception, theft by taking, and possession of a Schedule IV controlled substance.

there that knows something about this," said Blairsville PD Assistant Chief Michael "Bear" Baxter. "We need help in this case. It's crucial that we get any information that we can."

In a July 22 post to the BPD Facebook account, the department shared an account of the burglary and several screenshots taken from surveillance footage, and Baxter is hopeful someone will recognize the burglar.

"We do not like crime in our town, and hope to swiftly track down and arrest the person or persons responsible," reads part of the Facebook post.

The post continued: "They were wearing a navy colored ski mask or toboggan with holes cut into it, a navy colored shirt, camouflage shorts, and tan work boots with a black top on them.

"There is a picture of similar work boots listed with the photos. The criminal also

appears to have short hair, from what can be partially seen in video footage."

BPD is asking that

anyone with information about the Dunkin' Donuts burglary, including anonymous tipsters, call the 24-hour 911 nonemergency number at (706) 439-6038, or the Blairsville Police Department at (706) 835-1692. Individuals can also

Individuals can also contact the police department via Facebook, though, due to the ongoing nature of the investigation, the department is asking that people directly message the BPD Facebook account instead of posting information in the public comments section.

In order to minimize the impact of crimes like this one, law enforcement officials advise businesses to keep as little cash as possible in their stores afterhours, and to make regular deposits by close of business each day.
