Union General Hospital board assures public all is well

Nearly two weeks out from the very public arrests of Union General Hospital CEO Mike Gowder and Dr. Jim Heaton, the Union General Inc. Board of Directors is continuing its pledge to keep the public informed of the latest updates from the hospital.

"The biggest question that's come up to us, is the hospital going to close, and is it sound financially," said Board Vice Chair Jim Williams. "And the answer to that is, yes, we are financially sound, and the hospital is going to continue to operate as normal."

"Lewis Kelley is interim CEO, and the board is very engaged with being sure that the hospitals, all of our organizations, have the support

that they need to continue to do their jobs."

Williams added that, as additional information becomes available concerning the hospital in the aftermath of Gowder's departure, he and the board plan on keeping the public "in the loop."

Concerns over the fiscal solvency of the hospital have been brought to Williams' and Efrid's attention by members of the community.

"Whether it's a church or at the post office or at the grocery store, people will say, 'I understand you're on the board, is the hospital going to close,' or, what kind of shape are we in financially," said Williams. "The point is, we're financially sound - probably one of the most financially sound rural hospitals in Georgia, if not the country."

"We're trying to communicate effectively with our staff, with our physicians. We did have a meeting with the physicians and the medical staff on Tuesday (Feb. 9), Patsy and I did, to meet with them, to bring them in the loop of what was going on, and to let them know that we're depending on them to continue to do their jobs as they always have been, and to serve the public."

The Union General Board of Directors is composed of seven individuals appointed by either the commissioner or mayor, and approved by the board itself.

Currently, only six of the seven board members are considered active, as Dr. Heaton was appointed to the board last fall, but has since been suspended pending the board's ongoing internal investigation

into the allegations against the physician.

Patsy Efrid is chairman of the board, Williams is vice chair, and Dinah Paris, Max Cochran, Myron Turner and Steve Rowe make up the remaining active members.

"The board is very much united in our efforts to ensure that the hospital continues to operate as normal, and that we cooperate with law enforcement in any way they seek," said Williams. "If in the event that any information comes to our attention that needs to be communicated with our staff and the community, then we will do so."

Bond conditions of those arrested on Feb. 4 prohibit them from reaching out to any of the board members or anyone affiliated directly with the hospital, so Williams and

John Nix and Country Cousins honored

Live music was the theme of that gathering, which took place over several hours on Saturday, Feb. 6, and many of Nix's friends and family were there for support, including dozens of local and area musicians, many of whom have played with Nix throughout the years.

When he was 15 years old, Nix started the band with his brothers, Homer, Clayton and Cranford, and as for his "Country Cousins," quite a few of the folks he has played with over the years actually have been cousins, and others just friends, though he has always treated all like family.

Nix grew up part of a musical family, with one of his earliest influences being his mother, who played piano.

John was the youngest of his brothers, and they played all over Union County and beyond, including square dances, concerts, family reunions and funerals.

Cranford and Clayton Nix both have quite storied musical connections, as John tells it - Cranford spent time in Detroit recording with a multitude of artists at Motown Records, including with The Supremes.

And Clayton spent time with The King.

The Union County Board of Education voted in a special called meeting on Monday, Feb. 15, to declare Dr. Fred Rayfield as the single superintendent finalist to replace outgoing Superintendent Gary Steppe.

Rayfield is currently the superintendent of Decatur County Schools, where he has held that post since 2010.

"After a review of all applicants and a number of interviews, the board agrees that Dr. Fred Rayfield is the best qualified applicant for the position," said Board Chair Gary Daven. "The board is unanimous in its decision to name Dr. Rayfield as our single finalist."

One hundred seventy-five Vietnam Veterans from Towns and Union counties will be honored in a ceremony featuring Commissioner Mike Roby of the Georgia Department of Veterans Services on Wednesday, Feb. 17, at 4:30 p.m. in the Union County Schools Fine Arts Center.

Veterans will be awarded the state's Vietnam War Certificate of Honor, along with the Defense Department Commemoration Vietnam War Lapel Pin, all in recognition of their service during the war, and everyone is invited to witness the historic and special event.

"The Vietnam Veterans, very seldom are they ever honored by anybody," said Pat Phillips of Blairsville, who served three tours in Vietnam

Local pastor harassment hopefully at an end

Three juveniles have been taken into custody in connection with escalating harassment of a local pastor of a prominent Blairsville church.

On Monday, Feb. 1, the Blairsville Police Department responded to a call in which all four tires of the pastor's vehicle had been intentionally punctured with roofing tacks, according to Lt. Daren Osborn of the Union County Sheriff's Office.

Authorities believe that the tacks were placed behind the pastor's tires the night before at the church, so that after the Sunday service, the pastor would have backed over them before driving home.

But it wasn't until Monday that the pastor noticed

there was something wrong with his tires, and after taking his vehicle into the shop, he discovered that they had been flattened seemingly on purpose, according to Lt. Osborn.
